Hence, this deed of trust.

**NOW THIS DEED OF TRUST WITNESSETH AND IT IS HEREBY DECLARED AS UNDER:**

**I NAME AND ADDRESS OF THE TRUST:**

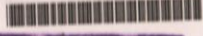
THAT, the name of the Trust shall be "**RAJENDRA SURIJI JAIN EDUCATION TRUST**". Further, the Office of the Trust shall be situated at R/o # 20 / 34, Gutti Peth, Main Bazaar, **SHAHAPUR - 585 223**, Tq: Shahapur, Dist: Gulbarga or at such other place/s, as the Trustees may deem fit and proper and decide from time to time at their requirements and directions for achieving the objects of the Trust.

**II CORPUS OF THE TRUST:**

As mentioned supra, the Settler has already contributed a sum of Rs. 5,001/- (Rs. Five Thousand One Only), towards the corpus of the Trust for the purpose of achieving the objects of the Trust. Further, the Trustee/s may collect and add funds to the said corpus by accepting the donations, gifts, in form of cash / money, kind, etc., from others in general, including property/ies such as site/s, house/s, land/s or other property/ies of all the kinds / natures whatsoever. The same shall always be available with the trust for the purpose of achieving the objects of the Trust. The Trust shall stand possessed with the said sum and profits, income and augmentation that may hereafter be collected / received by the Trustee/s under these presents and the properties for the time being representing the same, etc., (Hereinafter called / referred to as "**Trust Fund**"), upon the Trust & subject to the powers, provisions, agreements & declarations, hereinafter declared & contained of & concerning the same.

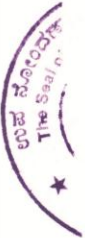

7) TO promote higher studies and research in all fields.

**B MEDICAL**

1) TO establish, run and / or maintain medical center/s, diagnostic center/s, hospital/s, charitable dispensaries, maternity home/s, nursing home/s, child welfare centers, convalescent homes, sanitariums, hostels, laboratories, test center/s sanatorium for the diagnosis and treatment of rehabilitation of all or any diseases, ailments, etc., whether physical, mental or psychological, accident relief center/s and other institutions.

2) TO conduct medical camps or blood donation camps for the diagnosis or treatment of or rehabilitation from all types of diseases or ailments.

3) TO carry on any other allied activity for providing medical relief or facility, distributing medicines, drugs, etc. creating awareness amongst the people and teaching and training people and development of all round physical and mental fitness and general health consciousness.

4) TO help needy persons to take Mediclaim or similar type of insurance policies to cover the medical expenses of the persons or his / her / their family/ies.

5) TO set up, maintain and run dispensaries, camps, shibirs and rehabilitation centers for the treatment of all or any type of diseases, ailments or accidents.

6) TO obtain bed, rooms, operation facilities and other conveniences in hospitals, health units for the needy by way of giving donations to the hospitals, health units as the case may be.

7) TO render free medical aid and to provide medicines either free of charge or at normal charge and for that purpose to purchase medicines or get medicines manufactured and also to reimburse the medical expenses to the needy person/s.

8) TO carry on any other allied activity for providing medical relief or facility, distributing medicines, drugs, etc., creating awareness amongst the people and teaching and training people and development of all round physical and mental fitness and general health consciousness.

9) TO assist other trust or organisation carrying on similar activities.

10) AND IN GENERAL to carry out / undertake all other medical activities in connection with the matters specified herein above.

Upon Trust in the first instance to collect dividend interest, rents, profits and other income to the Trust Funds and from and out of the same in the first place to pay all costs, charges and expenses of and incidental to the collection thereof and all outgoing payable in respect of the Trust Fund and any immovable property/ies for the time being subject to the Trust hereof as also the costs, charges and expenses of and incidental to the execution, management and administration of the Trust and powers herein contained.

Subject to the provisions of this deed, the Trustees shall hold the Trust Fund upon trust so that as far as practicable the Corpus shall remain intact and only the income thereof shall be used, but with liberty to the Trustees at their absolute discretion to use the Corpus from time to time either wholly or in part/s for achieving the aims and object of the Trust.

### III AIMS AND OBJECTS OF THE TRUST:

The following shall be the aims and objects of the Trust:

#### MAIN OBJECTS:

##### A EDUCATION:

- 1) TO establish, promote, take over, associate with and run and manage educational, medical and other charitable institutions such as nursery, primary and high school and college in the medium of Kannada, Hindi, English or any other language and shall be conducive and necessary for the propagation of knowledge.
- 2) TO establish, maintain and run all other types of educational institutions like schools, colleges, institutions, hostels, libraries, training centers, boarding and lodging for students, vocational guidance center/s, research center/s for providing knowledge in all fields and generally to promote all types of educational activities.
- 3) TO promote and impart education in all fields and generally to carry out all types of educational activities including character and moral building activities.
- 4) TO grant financial aid in the form of scholarships, loans, grants, aid, assistance, prizes, supplying text books, note books, educational material, tuition fees, free ships and to felicitate successful students for the promotion and advancement of education.
- 5) TO grant traveling fellowship or scholarship or loans with or without interest to deserving students for research and higher education in the country or abroad in various branches of technology, medicines, engineering, commerce, law, or any other branch of study or application.

- 6) TO set-up, maintain and run blind homes, destitute, handicapped, underprivileged, orphans, widows, homes for old aged, etc., or homes for the needy.
- 7) TO carry on any other activity that will promote social or socio-economic welfare of the people and strengthen the feeling of brotherhood and unity.
- 8) TO promote and make efforts for preserving the ancient Indian culture and heritage by constructing and maintaining art galleries, stadiums, meditation center/s, yoga classes, places for studying various cultural activities, etc., and to promote national integration, unity and culture.
- 9) TO help animals and birds by giving fodder, looking after the health and well being, give veterinary treatment, take care in all respect of animals, birds or any living species or to grow fodder for them and carry on activities related or incidental to the above objects.
- 10) TO take up activities for the relief of poor and removal of poverty in every shape or form including supply of medicine, food, clothing, shelters and providing sources of livelihood.
- 11) TO take up activities relating to conservation of natural resources, forestation, environment protection, preservation of ecology and such other allied activities.

**Power of the Board of Trustees:-**

The Board of Trustees shall have the following powers:-

- i) TO invest funds and collect interest thereon provided the conditions attached thereto are not in any way inconsistent with the proclaimed aims and objects of the Trust.
- ii) TO receive and collect donations, gifts in cash or kind, provided that the conditions attached thereto are not in any way inconsistent with the proclaimed aims and objects of the Trust and further provided that the said conditional donations have been accepted by at least 2/3<sup>rd</sup> majority of Trust Board.
- iii) TO borrow money, raise loans from any person, bank or financial institutions in such manner as the trustees shall think proper or convenient for the furtherance of the objects of the trust and for this purpose the trustees may secure repayment of these loans in any manner as may be decided from time to time.
- iv) TO open accounts in any Nationalised, Scheduled, Co-operative Banks in the name of the trust which shall be operated jointly by any two trustees as authorized by the Board of Trustees.
- v) TO frame rules and regulations for efficient management of the Trust.
- vi) TO add, amend, alter, vary and modify the rules and regulations framed by it.
- vii) TO purchase, sell, construct, lease, transfer otherwise, both movable and immovable properties. The board of trustees shall be the custodian of all the movable & immovable properties of the trust.
- viii) TO appoint auditors.
- ix) TO form committee or committees to achieve the objectives of the Trust. Such a committee may consist either some of the trustees or of some of the trustees together with any other person or persons whom the trustees may select provided that the trustees may at any time revoke either wholly or partly the authority so conferred on any such committee.
- x) TO appoint personnel to organize and promote the objects of the Trust and to regulate their conditions of service, including matters of discipline, etc.

xvi) The Board of Trustees shall be at liberty to take on hire or rent property for the Trust to carry out its objects.

**ACCOUNTING YEAR AND AUDIT:**

- The trustees shall cause true and complete accounts of the transactions of the trust to be kept and shall cause such accounts to be balanced as on the 31<sup>st</sup> day of March every year.
- A Balance Sheet shall be prepared as on the 31<sup>st</sup> day of March every year as well as a revenue and expenditure accounts for the twelve months ending with 31<sup>st</sup> March.
- The accounts of the trust shall be audited by Chartered Accountant appointed for the purpose who shall make report thereon to the members.
- The annual revenue and expenditure account and the balance sheet with the auditors report appended thereto shall be signed by the Board of Trustees along with the auditors and shall be placed before the members for adoption at their next annual general meeting.
- Auditors of the Trust shall be appointed by the general body in the annual general meeting and their remuneration would be fixed in every AGM.
- The auditor so appointed shall not be a Trustee on the Board of Trustees. The Auditor so appointed shall be a Chartered Accountant within the meaning of Chartered Accountants Act.
- The term of the auditor shall be till the conclusion of the next annual general meeting of the trust. The retiring auditors shall be eligible for re-appointment.

**X ARBITRATION:**

The Trust Board shall have power to compromise or compound or submit to arbitration all actions, suits and other proceedings and all difference/s and disputes touching the Funds, Assets, Estate or matter of the Trust and refer any such difference/s, dispute to Arbitration and act on the arbitration award and settle all accounts, acts, deeds, or things arises there from.

**XI LEGAL PROCEEDINGS:**

The Trust may sue or be sued in its name. Any proceedings of the Court by or against the Trust shall be signed by the Chairman or such other Trustee, as may be especially empowered for that purpose, by a resolution in writing by the Board of Trustees, in the meeting of the Trust. In the absence of any such a resolution, the Chairman shall look after the same. The Chairman or such empowered Trustee shall have all the powers to take necessary decision in the interest of the Trust.

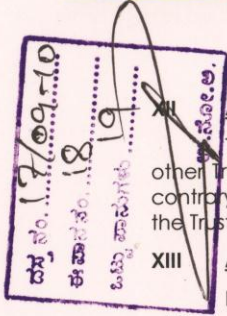

**XII AMALGATION:**

The Trust may after taking a meeting and decision therein, get amalgamated any other Trust of which the common aims and objects are in conformity with and are not contrary to the aims and objects of this Trust. However, in any such event, the name of the Trust shall not be changed or altered.

**XIII AMENDMENTS, ETC.**

No amendments, additions, deletions, alterations or changes to the aims and objects and the clauses of the Trust Deed of this Trust shall made / carried out, which are contrary to the law of the land. If such amendments, additions, etc., are carried on, the same shall be treated as if not done. The Board of Trustees shall have the powers to amend, alter or rescind any of the provisions of this Trust Deed in a manner not inconsistent with the objects of the Trust and to interpretate their meanings, if ambiguous and whenever the rules and regulations framed do not cover the situations so arrived and for the purpose of attainment of the objects of the Trust. Further, the Trust shall have absolute discretion to amend or alter any of the clause/s of this Trust Deed including the objects of the Trust.

**XIV DISSOLUTION OF THE TRUST:**

If the Board of trustees unanimously decides to dissolve the trust, the Board shall have full power to distribute and /or dispose of the properties of the trust as it thinks fit and proper.

**XV MISCELLANEOUS:**

- The Trustees shall be entitled to draw such allowances as prescribed by the Board from time to time for carrying out their duties.
- The funds of the Trust shall be invested in the items referred under the Sub-section 5 of Section 2 and be invested in the modes specified under the provisions of section 13(1)(a) read with Section 11 (5) of the Income Tax Act and further the same shall not be utilized for the benefit of any persons/s referred in section 13 (3) of the Income Tax Act.
- In the event of revocation of Trust or dissolution of the Trust all the properties of the Trust including the cash in hand, etc., shall devolve absolutely to the Founder Trustees / Settler or their heirs, assignees, etc., and none of the other Trustees shall have any right or claim, etc., over such Trust Property, of any kind whatsoever.
- The Settler and trustees (who are also the Trustees for life) of the Trust shall not be personally liable for any of the acts done for and on behalf of the Trust and in the capacity of their being holding any of such post in the Trust.
